ELIGIBILITY- Applicants must be:

1. An active member of a Santa Clara County youth organization & resident of Santa Clara County
2. At least a junior in high school
3. Willing and able to raise a hog to be sold at the Santa Clara County Fair Youth Auction, ALL proceeds of which will go directly to the Clover Foundation.

The Clover Foundation will: 1) Purchase the Heritage Hog 2) Reimburse feed and veterinary care expenses.

The successful designee will successfully complete **“The Project”**.

“THE PROJECT” will consist of completion of ALL the following items:

- 1) Transportation of the Hog purchased by the Clover Foundation to the designee’s facility.
- 2) Proper feeding, care (including veterinary care if necessary), exercise, training and fitting of the Hog for Show presentation at the Santa Clara County Fair.
- 3) Attendance and promotion of the Heritage Hog Program to at least 6 events, organizational meetings or Community programs to engage support for buying the animal at auction.
- 4) Enter, transport, Show and present the animal at auction at the Santa Clara Co. Fair.
- 5) Provide all thank-you notes to buyers of animal.

For successful completion of The Project, the designated winner will earn and receive a \$5000 Scholarship.

TO APPLY FOR SCHOLARSHIP, APPLICANTS WILL:

1. Submit completed application.
2. Submit the ‘Clover Heritage Hog Agreement’, with ALL signatures:
 - a) Applicant
 - b) Parent/Guardian
 - c) Youth Organization Leader
3. Submit 2 letters of recommendation - one from an advisor/leader, one from a non-family member
4. Submit the Clover Heritage Hog Fair Exhibitor agreement, signed
5. Submit an individual photo, either color or black and white, which may be used for publicity purposes (photos and application sent become the property of the Clover Foundation).
6. Participate in an interview
7. Give a 3-minute presentation on ‘Youth in Agriculture’ to the interview judges.
8. Clover Foundation Heritage Hog applicants who do not win the scholarship may submit the same application for the Clover Foundation Spring Scholarship

Applications are **DUE** to the Clover Foundation **FRIDAY, MARCH 5, 2022**. (Must be postmarked by Jan 28, 2022). Interviews date is still yet to be determined at a location and time to be determined.

2. **Judging Criteria** – for your own information – does not require completion. This shows the points given in the evaluation of each part of the Application Process.
3. **Recipient Terms and Conditions – Please read carefully.** This is your agreement to the terms of the Scholarship and must be fully signed and dated by the Applicant, the Applicant’s Parent/Guardian and the Applicant’s Project Leader/FFA Advisor.
4. **Exhibitor/Fair Heritage Hog Proceeds Agreement.** Please read carefully. This is the agreement acknowledging that you fully understand that all of the proceeds from the sale of the Heritage Hog will be assigned directly to the Clover Foundation of Santa Clara County. You will receive a separate check from the Clover Foundation for the \$5,000 Scholarship earned in exchange for caring for, feeding, vetting, fitting, showing and selling the Clover Foundation Heritage Hog. This must be printed out and signed by the Applicant and returned with the application. The Clover Foundation will secure the signature of the Fair Manager.
